On about January 27, 1992, the Agents changed office furniture configuration in such a way as to disadvantage certain bargaining unit employees.  2. On about February 3, 1992, the Agents established down time schedules for certain bargaining unit employees.  The Charged Party committed these violations despite the fact that he had agreed, in settlement of ULP Charge Case No. 76-CA-1087, to furnish the Union with proper advance notices of all future proposed changes in conditions of employment.
