Dear RC Schuenemeyer:

By this letter, AFGE Local 2505 files a Section 10 grievance because Magda Mashburn (OKC) and Mary Roberts (Moore) were charged incorrect annual leave the week of August 24 when they attended the AFGE National Convention on behalf of AFGE Local 2505.

Ralph de Juliis, Local 2505 President was only charged 16 hours of leave for that week, which is correct. Ms Roberts was charged 24 hours of annual leave. This should be corrected to 16 hours of annual leave. Ms Mashburn was charged 17 hours of annual leave as August 25 was her CWS day. August 27 was considered her 8 hour day; August 28 was considered her 9 hours work day. She should have been charged on 8 hours of annual leave.

After someone cancelled Magda Mashburn's already approved official time request for that week, OKC ADM Janis Jones told Ms Mashburn that she would have to request annual leave for 2 days (August 27 and August 28) taking into account her August 25 CWS day. Ms Mashburn informed Ms Jones that Ralph de Juliis was only charged 16 hours of leave. OKC ADM Janis Jones said she

would check and get back with Magda who was going to let Mary Roberts and her District Manager, Dennis Purifoy, know. She never got back to anyone.


The Union requests an oral presentation.

I will be the Union's representative.

SSA's charging Ms Mashburn and Ms Roberts excessive leave is discriminatory based on their sex (female). It violates SSA travel time policies. The remedy requested by the Union is that both Ms Mashburn and Ms Roberts have their annual leave for that week changed from 24 hours to 16 hours for Ms Roberts and from 17 hours to 8 hours for Ms Mashburn.

SSA has violated Article 1, Sections 1 and 2; Article 2 A and B; Article 3, Section 2; Article 18, Section 1; and Article 30, Sections 1, 5 and 8.

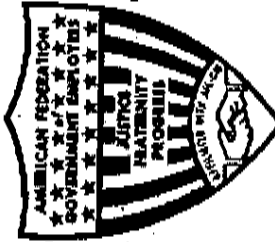
