Dear Regional Commissioner Schuenemeyer:

By this letter, AFGE Local 2505 files another Article 24, Section 10 Union-Management Grievance over the failure of SSA to properly annotate the payroll deduction list it provides to AFGE Local 2505.

This grievance is about the failure of SSA to notify AFGE Local 2505 that a member was dropped from payroll deduction.

McAlester Union member Jose Olivero was promoted to AWC PAS. When his promotion took effect, newly AWC PAS Olivero was dropped from Local 2505 payroll deduction. SSA FAILED to annotate the drop on the payroll deduction list it provided to AFGE Local 2505 for the pay period ending PPE 4-12-08.

The failure to provide such notice to the Union violated Article 6, Section 3, D.2.



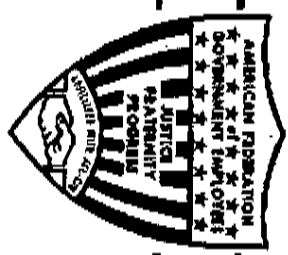
