On or about 9/12/07 a grievance was filed. An information request was made concerning that grievance on 9/14/07. The Union followed up on the information request on 9/25/07. SSA's agent, Janis Jones, replied, "I am still working on your request. I will respond as soon as possible." The Union made a 2nd follow up on 9/28/07. SSA's agent, Janis Jones, read the email on 10/5/07 but did not respond. On 10/22/07, the Union made a 3rd follow up. On 10/23/07, SSA's agent, Janis Jones, replied: "I apologize for the delay. I am working with the regional office to get an answer for your request. Just FYI, Mike and I have switched back to our original positions. We will work to get a response for you within a week." On 11/9/07, the Union made its 4th follow up. On 11/9/07, SSA's agent, Janis Jones, deleted the Union's 4th follow up without reading it. As of this filing, the Union has received no information from SSA nor any indication of when a response might be forth coming.

By its actions, failure to substantively reply the the Union's Information Request and finally, its deletion of the Union's follow ups without reading them, SSA has violated 5 USC 7114 (a) (1)(5) and (8)
