Dear Regional Commissioner Schuenemeyer:

By this letter, AFGE Local 2505 **ADDS** and **AMENDS (yet again)** the comprehensive Section 10 grievance of Oklahoma Management's repeated and willful violations of Article 6, Section 3 and Article 24, Section 10 of the AFGE-SSA National Agreement.

On the dues withholding list for PPE 12-26-08 received by Local 2505 Secretary-Treasurer Magda Mashburn, SSA has yet again failed to transfer the union dues withholding from Local 2505 to the correct AFGE Locals for (a) Jenny Le who is now in Brea, CA DO # D39, (b) Kelvin Corbin who is now in Texarkana, TX, (c) Mitchell Edmondson who is now in Central Office in PRSB/OAISIS, DSSIMS, DCS and (d) Erica Harris who is now in Vidalia, GA.

SSA has also failed to return Dianne Turner (Muskogee, OK SSA Field Office) to payroll dues withholding. Her detail to a non-bargaining unit position ended on November 21, 2008.


The Union cannot adequately express its displeasure with SSA's long-term, repeated failure to fulfill its obligations to AFGE under Article 6. These are not new provisions. They have been around since the first national agreement! After 25 years and all of the money SSA has spent on computerization and automated scripts, SSA's inability to comply with Article 6 after multiple grievances can only be viewed as willful and malicious.

As remedy, the Union wants 4 hours of NON-OUTTS official time every pay period for the Local's Secretary-Treasurer Magda Mashburn to manually check every payroll deduction list for SSA errors. Additionally, the Union requests the posting which follows in every office in the jurisdiction of Local 2505.

The remedy the Union seeks is that SSA reimburse the appropriate AFGE locals the appropriate amount of dues SSA has failed and refused to improperly withhold. Additionally, Local 2505 seeks SSA's payment of our dues(\$13.95) for every pay period that SSA has failed to withhold the Union dues of Dianne Turner.

The Union wishes to make an oral presentation of this grievance. I will be the Union's representative. Local Secretary-Treasurer Mashburn will be a witness.
